1. Introduction

Capital Goods & Strategic Skill Council (CGSSC) is an apex body been designed to bridge the gap between manufacturing industry needs of skilled manpower as per competency standards defined by the industry and the training and education system.

The Council is promoted by Industries, Ministry of Heavy Industries (MHI), & Ministry of Skills Development & Entrepreneurship (MSDE), Govt. of India.

CGSSC invites the Expression of Interest (EOI) from Training Partners preferably having experience in running training programs projects in manufacturing Sector under various Job roles under CGSSC 'Eligibility Criteria'.

All the agencies mentioned above should:

- Be a registered legal entity
- Not blacklisted by any Donor Agency/ State Government/ Central Government/ any competent authority.
- Have not defaulted previously for any order awarded by the Council.
- Will adhere to respective schemes norms (as amended from time to time).
- Training facilities should be available within State/ Districts / Region
- Having 3+ years of training experience and with good network of industries within Tamilnadu for placement of candidates locally.
- Preference will be given to those who are already Council's affiliated training partners in Tamil Nadu.

2. Tender Cost (Non-Refundable)

All applicants are requested to submit a non-refundable Tender Cost of Rs. 7,500/- (Rupees seven thousand five hundred only). This will be paid in the form of a Demand Draft/NEFT (CSB Bank A/C No. 0458010000305, IFSC: CSBK0000458) in favor of "**Capital Goods & Strategic Skill Council**" payable at New Delhi, drawn on any scheduled commercial bank and must accompany with Covering Letter in the cover of the Proposal Document. Proposals that are not accompanied by the proposed Tender Cost shall not be considered.

3. Indicative Timelines

The application should reach by 30th June 2026 through online submission/physical submission. No further submission will be entertained after 30th June 2026.

4. Duration of Empanelment

The duration of the empanelment will be max. 3 months, which may be extended based on the Training Partner's performance.

The CGSSC reserves all the right to discontinue/ de-affiliate the Training Partner at any time in case of non-performance without any notice.

5. Cost Norms

Skill Development training costs would be paid as per as per the Tamil Nadu Skill Development Corporation (TNSDC) guidelines applicable to this Project.

6. Training Infrastructure

As per TNSDC & Sector Skill Council (SSC) Guidelines.

7. Placement

The empaneled Training Partner shall strive to provide placement to all the trained candidates in the State of Tamil Nadu. However, CGSSC mandates the training partner to place a minimum 80% of the trained candidates. Relocation shall be allowed only with the explicit consent of the candidates.

8. Selection Process

Eligible entities to be called to present their detailed proposal before a selection committee and the decision of this committee shall be final. Selected training partners will have to sign a Memorandum of Understanding (MoU) with CGSSC. Entities that were shortlisted in the previous Expression of Interest (EOI) process are not eligible to apply.

9. Project compliance

Failure by any Training Partner to complete the project within the stipulated timelines shall invite monetary penalty up to 25% of the total project value and constitute grounds for revocation of the Work Order by CGSSC.

10. Submission of Proposal
